

WAIVER, PROMISE, RELEASE AND INDEMNITY AGREEMENT

By my signature below, I affirm that I am of lawful age and legally competent to execute this document or have obtained the written consent of my parents or guardians to execute this document. I have been well advised and thoroughly informed of the inherent hazards of entering onto the premises (the "Premises") operated by **PrideRock Wildlife Refuge**. I understand and acknowledge that the **Premises hold dangerous wild animals and that entering on the Premises is hazardous and involves risks**. I hereby personally assume all such risks in connection with entering onto the Premises, whether foreseen or unforeseen, and I wish to enter onto the Premises in spite of the danger and risks involved in doing so. **I UNDERSTAND THAT I CANNOT APPROACH ANY ANIMAL ENCLOSURE, AND MUST REMAIN A MINIMUM OF 3' FROM ALL ENCLOSURES, AND MUST NOT TOUCH OR ATTEMPT TO TOUCH ANY ANIMAL.**

In consideration for access to the Premises, **THE UNDERSIGNED HEREBY WAIVES ALL LIABILITY, RELEASES AND INDEMNIFIES PRIDEROCK WILDLIFE REFUGE AND ITS OFFICERS, DIRECTORS, EMPLOYEES, AND AGENTS (the "RELEASEES") FROM ANY AND ALL LIABILITY OF EVERY TYPE AND CHARACTER WHATSOEVER, INCLUDING, BUT NOT LIMITED TO, THE NEGLIGENCE OF THE RELEASEES AS MORE FULLY SET FORTH HEREIN.**

Release and Waiver.

The undersigned hereby releases, waives and discharges ("Releases") for the undersigned, the undersigned's heirs, Minors (as herein defined), executors, administrators, representatives, and assigns, the Releasees from and against any and all liabilities (including, without limitation, liability for personal injury, property damage, or wrongful death), claims, demands, costs, expenses (including, without limitation, attorneys' fees and expenses and medical fees and expenses), damages, losses or debts (collectively the "Damages") which the undersigned, or which the undersigned's minor children or any and all other minors in the care or custody of the undersigned (collectively, the "Minors") incur or suffer at any time, either directly or indirectly, arising out of or in connection with the undersigned and/or the Minors having access to the Premises and/or participating or taking part in any activity on the Premises regardless of the cause of such damages, including, but not limited to, the negligence of the Releasees,

Promise Not To Sue and Indemnify

The undersigned covenants and agrees for the undersigned, the undersigned's heirs, minors, executors, administrators, representatives and assigns, to never institute, prosecute, or assist others to institute or prosecute, or in any way aid claim, suit or action of any kind whatsoever, at law, in equity, statutory, or otherwise, against any or all of the Releasees arising out of or in connection with the undersigned or the Minors having access to the Premises and/or participating or taking part in any activity on the Premises regardless of the cause of such Damages, including, but not limited to, the negligence of the Releasees.

THE UNDERSIGNED HAS READ, UNDERSTANDS AND VOLUNTARILY SIGNS THIS WAIVER OF LIABILITY, PROMISE NOT TO SUE, RELEASE AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or other inducements apart from the foregoing written agreement have been made. The undersigned hereby agrees that any photos of felines taken at the Premises shall be used for personal use only. No commercial or other use or publications are allowed without prior written consent of PrideRock Wildlife Refuge.
